AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE CITY OF ROCKY RIVER, SPECIFICALLY SECTION 951.01 ENTITLED FEES, PERTAINING TO THE MUNICIPAL SWIMMING POOL, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT "A"

WHEREAS: on March 23, 2020 through Ordinance No. 22-20 Rocky River City Council and the Mayor approved the current swimming pool fee schedule for the Rocky River recreational pool users, as provided in Rocky River Codified Chapter 951, entitled "City Swimming Pool"; and

WHEREAS: it is the opinion of the Administration and Council of the City of Rocky River that Section 951.01 of the Codified Ordinances be amended to reflect the changes to the fees associated with use of the municipal swimming pool effective January 1, 2022, as further described in the attached Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That Section 951.01 of the Codified Ordinances of the City of Rocky River entitled "Fees" be amended as further described in the attached Exhibit "A".

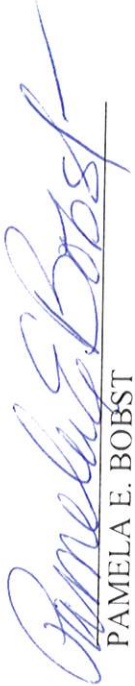

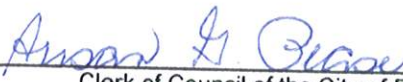

IV. DEFINITIONS

<u>Senior:</u>	Rocky River Resident age 60 or older, must present proof of age and residence
<u>Adult:</u>	Age 18 or older and not in senior high school as of June 1st.
<u>Student:</u>	Ages 5-17 and/or student as of June 1 in elementary, junior or senior high school, or 18 and still in high school
<u>Child:</u>	Ages 3-4
<u>Infant:</u>	Age 2 and under as of June 1
<u>Family:</u>	Up to 2 adults residing at the same address, their children of whom they are legal guardians who are under 18 or still in high school. Full-time college students with current college ID's, ages 18-22, will be considered part of the family plan.
<u>Affiliate:</u>	Non Resident Civic Center Member or Non-Resident Rocky River Business employee (Must be non-resident and an employee of a Rocky River business and provide appropriate verification of employment)

Friends and Family: Friends or family members of Civic Center members or resident pool pass holders that are recommended by the Civic Center members or resident pool pass holders for a pool membership. A maximum of 200 passes will be sold for Friends and Family.
