AN EMERGENCY ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY SERVICE TO PURCHASE VEHICLE MAINTENANCE PARTS FOR THE CITY OF ROCKY RIVER FOR A TWO (2) YEAR PERIOD FROM CAR PARTS WAREHOUSE WITH AN OPTION TO RENEW AT A COST NOT TO EXCEED \$55,000 PER ANNUM, AS FURTHER DESCRIBED IN EXHIBIT "A".

WHEREAS: the Director of Public Safety Service advertised for bid for the purchase of vehicle maintenance supplies to service the city of Rocky River's vehicles for a two (2) year period with an option to renew; and

WHEREAS: two (2) bids were received for the purchase of said parts, copies which are in file in the Safety Service office; and

WHEREAS: the Director of Public Safety Service has determined it to be in the best interest of the City of Rocky River to accept the bid from Car Parts Warehouse, 5200 W. 130th St, Brook Park, Ohio 44142, for a two (2) year period not to exceed Fifty Five Thousand Dollars and 00/100 (\$55,000.00) per annum, as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety Service is hereby authorized to purchase vehicle maintenance parts for the City of Rocky River from Car Parts Warehouse, 5200 W. 130th St, Brook Park, Ohio 44142, for a two (2) year period not to exceed Fifty Five Thousand Dollars and 00/100 (\$55,000.00) per annum, as further described in Exhibit "A".

SECTION 2. That funds for the purchase of vehicle maintenance parts shall be paid from the General, Senior Center, Sanitary Sewer, Street Construction Maintenance and Repair, Recreation, Waste Water Treatment Plant Utility, Refuse and Recycling, Marine Patrol and Municipal Motor Vehicles Funds.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety and to immediately implement cost saving opportunities for the Service Division, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

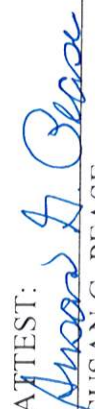

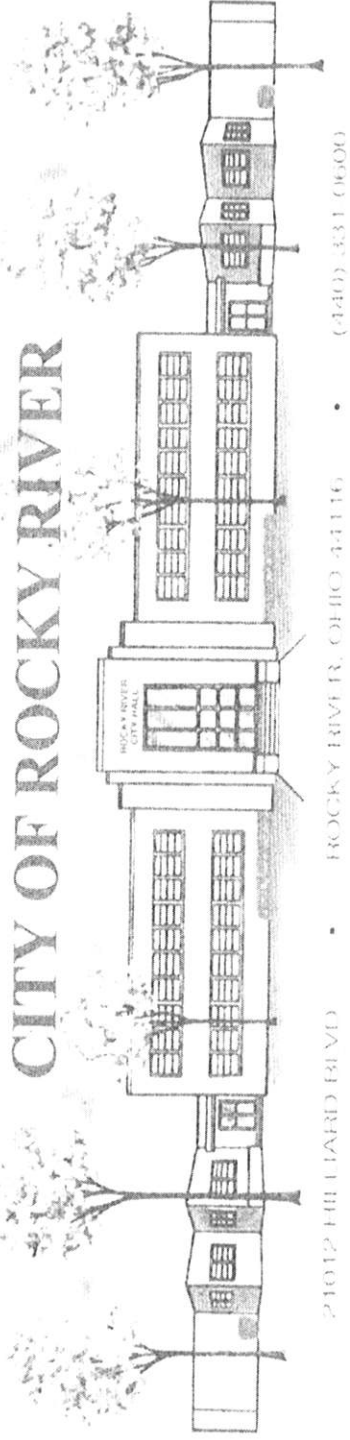
