A RESOLUTION AUTHORIZING THE CERTIFICATION OF UNPAID PROPERTY
MAINTENANCE COSTS TO THE CUYAHOGA COUNTY
FISCAL OFFICER FOR COLLECTION IN ACCORDANCE WITH THE
LAWS OF THE STATE OF OHIO AND AS FURTHER DESCRIBED IN THE ATTACHED
EXHIBIT "A"

WHEREAS: During 2020, the City of Rocky River provided property maintenance to certain unkempt properties in the City, and;

WHEREAS: The affected property owners have been invoiced for such service, and on February 5, 2021, the Director of Finance mailed letters to the affected property owners requesting payment of the past due amount by March 5, 2021, and

WHEREAS: The Ohio Revised Code requires that special assessment certifications be received to the Cuyahoga County Fiscal Officer by the second Monday in September, and

WHEREAS: Certain of said obligations remain outstanding and unpaid as indicated on the attached Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1: That the amounts identified and set forth in Exhibit "A" which is attached hereto and made a part hereof, shall be certified to the Cuyahoga County Fiscal Officer for collection in accordance with Ohio Revised Code Section 729.49.

SECTION 2: That the amount shown for each address and permanent parcel number be and is hereby assessed against such property and the Clerk of Council and Director of Finance are hereby authorized to certify said unpaid property maintenance costs to the Cuyahoga County Fiscal Officer for collection in accordance with the general laws of the State of Ohio.

SECTION 3: That said collection shall be in two equal payments over the next tax year.

SECTION 4: That the Director of Finance is hereby authorized to eliminate from assessment those accounts which pay the delinquency or for which adjustment is found to be required.

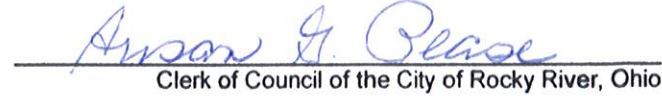
