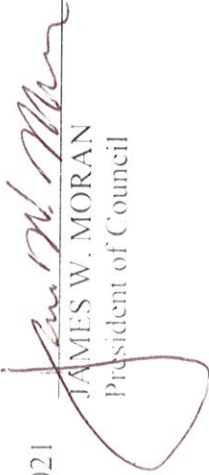
AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE CITY OF ROCKY RIVER, SPECIFICALLY SECTION 957.01 ENTITLED USE FEES, PERTAINING TO ELMWOOD PARK CABIN, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT "A"

WHEREAS: on April 24, 2017 through Ordinance No. 13-17 Rocky River City Council and the Mayor approved the current fee schedule for Rental and Use Fees pertaining to Elmwood Cabin, as provided in Rocky River Codified Chapter 957.01, entitled "Elmwood Park Cabin"; and

WHEREAS: it is the opinion of the Administration and Council of the City of Rocky River that Section 957.01 of the Codified Ordinances be amended to reflect the changes to the fees associated with use of Elmwood Cabin, as further described in the attached Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That Section 957.01 of the Codified Ordinances of the City of Rocky River entitled "Fees" be amended as further described in the attached Exhibit "A".

957.01 ELMWOOD CABIN RENTAL & USE FEES

“Resident” as used in this Section means a group of which fifty percent (50%) or more of all members are residents of the City of Rocky River. “Non-Resident” means a group with a majority of members residing outside of Rocky River. The following fees shall be charged for use of the Elmwood Park Cabin:

A. RESIDENT WEEKDAYS	
Morning	\$100.00
Afternoon/Evening	\$150.00
All Day	\$225.00

B. NON-RESIDENT WEEKDAYS	
Morning	\$150.00
Afternoon/Evening	\$250.00
All Day	\$375.00

C. RESIDENT WEEKENDS	
All Day	\$250.00

D. NON- RESIDENT WEEKENDS	
All Day	\$375.00

E. OVERNIGHT RENTAL	
Resident	\$400.00
Non-Resident	\$500.00

- F. Residents may begin booking one year from the month of their event.
- G. Non-Residents may begin booking no sooner than six months from their event date.
- H. In recognition of reciprocal use of school facilities, fee will be waived for select Rocky River Board of Education school-sponsored activities (i.e. clubs, athletic teams), subject to approval by Director of Recreation.
- I. Failure to abide by the rules established for the use of any park space may result in loss of future rental privileges as determined by the Director of Recreation.
