WHEREAS: the Director of Public Safety Service offered for sale through public bidding a 2004 New Holland Backhoe which is being removed from the City fleet; and

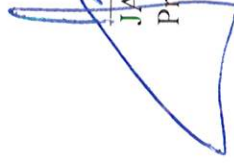
