AN AMENDED EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND THE DIRECTOR OF PUBLIC SAFETY SERVICE TO SELL USED CITY VEHICLES WHICH WERE OFFERED FOR SALE THROUGH PUBLIC BIDDING FOR A TOTAL SUM OF \$15,753.03

WHEREAS: the Director of Public Safety Service offered for sale through public bidding vehicles which are being removed from the City fleet; and

WHEREAS: on December 4, 2020 eight (8) bidders submitted bids for the vehicles, copies of which are available for inspection in the office of the Director of Public Safety Service; and

WHEREAS: Three (3) bidders presented the best bids for vehicles being removed from the City fleet, as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Mayor and the Director of Public Safety Service are hereby authorized to sell to the three (3) highest bidders, vehicles being removed from the City fleet, as further described in Exhibit "A".

SECTION 2. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety and the sale of said vehicles is necessary so that the vehicle fleet may be updated, provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
