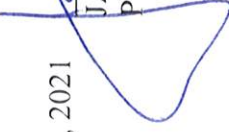

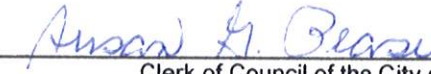

1501.01 ADOPTION.

(a) There is hereby adopted by the Municipality, the 2011 Ohio Fire Code (OFC), along with any subsequent revisions thereto, **and as amended from time to time** as adopted by the Ohio Division of State Fire Marshal, Department of Commerce, effective November 1, 2011, and as published in Division 1301:7 of the Ohio Administrative Code (OAC).

(b) The following amendments, substitutions, additions and deletions to the Ohio Fire Code are described in subsection (a) above and are hereby adopted:
Section (c) 307.4.3 Exception: Portable outdoor fireplaces used at one- and two-family dwellings. Is deleted.

Section (d) 308.1.4 Exceptions: 1. One- and two-family dwellings. Is deleted.

Section (d) 308.1.4 Exceptions: 2. Where buildings, balconies and decks are protected by an automatic sprinkler system. Is deleted.
