AN ORDINANCE AUTHORIZING THE DIRECTOR OF FINANCE TO PAY THE CITY OF CLEVELAND, DIVISION OF WATER THE AMOUNT OF \$33,775.08 FOR WATER METER READINGS NEEDED BY THE CITY OF ROCKY RIVER FOR THE PERIOD FROM MARCH 1, 2021 TO FEBRUARY 28, 2022, AS DESCRIBED IN THE ATTACHED EXHIBIT "A"

WHEREAS: The City of Rocky River bases resident charges for sanitary sewer discharge on the amount of the residents' water usage provided by the City of Cleveland, Division of Water; and

WHEREAS: An annual reading of the residents' water meters is needed for calculating sanitary sewer charges; and

WHEREAS: The aggregate charge from the City of Cleveland, Division of Water for the water meter readings is \$33,775.08.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. - That the Director of Finance is hereby authorized to pay the City of Cleveland, Division of Water for the water meter readings needed by the City of Rocky River as described in the attached Exhibit "A" in the amount of \$33,775.08 for the period from March 1, 2021 to February 28, 2022.

SECTION 2. - That the funds for the payment of these meter readings shall be paid from the Sanitary Sewer Fund.
