AMENDED RESOLUTION NO. 4222

A RESOLUTION AUTHORIZING THE CERTIFICATION OF DELINQUENT SANITARY SEWER ACCOUNTS TO THE CUYAHOGA COUNTY FISCAL OFFICER FOR COLLECTION, IN ACCORDANCE WITH THE LAWS OF THE STATE OF OHIO AND AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT "A"

WHEREAS: The City of Rocky River charges sanitary sewer fees in accordance with City of Rocky River, Codified Ordinances, Section 914.15, and

WHEREAS: Certain sanitary sewer accounts have accumulated charges and fees that are past due as of December 31, 2021, and

WHEREAS: On June 15, 2022, the Sewer Charge Administrator mailed letters to the addresses listed on said past due accounts requesting payment of the past due amount by July 15, 2022, and

WHEREAS: The Ohio Revised Code requires that special assessment certifications be received to the Cuyahoga County Fiscal Officer by the second Monday in September, and

WHEREAS: The accounts indicated on the attached Exhibit "A" remain unpaid.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

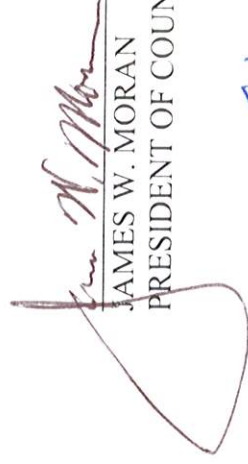
SECTION 1: That the past due sanitary sewer accounts identified and set forth in Exhibit "A" which is attached hereto and made a part hereof, shall be certified to the Cuyahoga County Fiscal Officer for collection in accordance with City of Rocky River, Codified Ordinances, Section 914.15 and the general laws of the State of Ohio, on or after July 26, 2022.

SECTION 2: That the amount shown for each address and permanent parcel number be and is hereby assessed against such property and the Clerk of Council and Director of Finance are hereby authorized to certify said past due sanitary sewer accounts to the Cuyahoga County Fiscal Officer for collection in accordance with the general laws of the State of Ohio.

SECTION 3: That said collection shall be in two equal payments over the next tax year.

SECTION 4: That the Director of Finance is hereby authorized to eliminate from assessment those accounts which pay the past due amount or for which adjustment is found to be required.
