AN ORDINANCE AMENDING THE CODIFIED ORDINANCES OF THE CITY OF ROCKY RIVER, SPECIFICALLY SECTION 953.02 ENTITLED FEES, PERTAINING TO ROCKY RIVER MUNICIPAL ICE SKATING RINK, AS FURTHER DESCRIBED IN THE ATTACHED EXHIBIT "A"

WHEREAS: on May 10, 2021 through Ordinance No. 20-21 Rocky River City Council and the Mayor approved the current fee schedule for Rental and Use Fees pertaining to Hamilton Ice Arena, as provided in Rocky River Codified Chapter 953.02, entitled "Rocky River Municipal Ice Skating Rink"; and

WHEREAS: it is the opinion of the Administration and Council of the City of Rocky River that Section 953.02 of the Codified Ordinances be amended to reflect the changes to the fees associated with use of Hamilton Ice Arena, as further described in the attached Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That Section 953.02 of the Codified Ordinances of the City of Rocky River entitled "Fees" be amended as further described in the attached Exhibit "A".
