AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO ENTER INTO AN AGREEMENT WITH PVS TECHNOLOGIES, INC. FOR THE PURCHASE AND SUPPLY OF FERRIC CHLORIDE FOR THE ROCKY RIVER WASTEWATER TREATMENT PLANT AT A COST OF \$1173.00 PER DRY TON FOR ONE (1) YEAR AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: The Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that contain an option to renew on an annual basis for the purchase and supply of Ferric Chloride for the Wastewater Treatment Plant starting January 1, 2023; and

WHEREAS: October 18, 2022, two (2) bids were received and upon recommendation of the Waste Water Treatment Plant Superintendent, it was determined to be in the best interest of the City to accept the lowest and best bid for the purchase and supply of Ferric Chloride for the Wastewater Treatment Plant from PVS Technologies, Inc. for a period of one (1) year, copies of bids are on file in the office of the Director of Public Safety Service; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase services for the supply of Ferric Chloride for a period of one year, with an option to renew from PVS Technologies, Inc., 10900 Harper Avenue, Detroit, MI 48213 at \$1173.00 per dry ton

SECTION 2. That funds for the purchase and supply of Ferric Chloride shall be paid from the Wastewater Treatment Plant Utility Fund.
