ORDINANCE NO. 73-22

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO ENTER INTO AN AGREEMENT WITH JAMES DIAZ FARM FOR THE REMOVAL OF DIGESTED SLUDGE CAKE (SUMMER SEASON) FOR THE WASTEWATER TREATMENT PLANT AT A COST OF \$46.00 PER TON FOR ONE (1) YEAR AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: The Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that contain an option to renew on an annual basis for the removal of digested sludge cake for land application from the Wastewater Treatment Plant; and

WHEREAS: October 18, 2022, one (1) bid was received and upon recommendation of the Waste Water Treatment Plant Superintendent, it was determined to be in the best interest of the City to accept the lowest and best bid for the removal of digested sludge cake (summer season) from the Wastewater Treatment Plant from James Diaz Farm, for a period of one (1) year, copies of bids are on file in the office of the Director of Public Safety Service; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase services for the removal of digested sludge cake (summer season) for a period of one year, with an option to renew from James Diaz Farm, 66 State Rout 58, Sullivan, Ohio 44880 at the price of \$46.00 per ton.

SECTION 2. That funds for the removal of digested sludge cake to a municipal landfill shall be paid from the Wastewater Treatment Plant Utility Fund.
