AN ORDINANCE AUTHORIZING THE SAFETY SERVICE DIRECTOR TO PURCHASE GASOLINE, FUEL OIL AND ALLIED PRODUCTS ON THE OPEN MARKET AT THE BEST PRICES POSSIBLE FOR THE PERIOD JANUARY 1, 2024 TO DECEMBER 31, 2024

WHEREAS: The City of Rocky River needs to secure gasoline fuel and allied products in order to continue the level of services for the City's operations; and

WHEREAS: the gas and fuel oil prices fluctuate in such a manner that compiling competitive quotes regularly from the open market is necessary to find the best prices available.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety Service Director is hereby authorized to purchase gasoline, fuel oil and allied products for the City of Rocky River for the period of January 1, 2024 through December 31, 2024 on the open market and at the best prices available.
