AN ORDINANCE AUTHORIZING THE SAFETY SERVICE DIRECTOR TO PURCHASE TIRES ON THE OPEN MARKET AT THE BEST PRICES POSSIBLE FOR THE PERIOD JANUARY 1, 2024 TO DECEMBER 31, 2024

WHEREAS: The City of Rocky River needs to secure tires and allied products in order to continue the level of services for the City's operations; and,

WHEREAS: the City purchases tires in a variety of sizes and grades for vehicles in all of the departments and divisions of the City; and,

WHEREAS: the tire market prices fluctuate in such a manner that compiling competitive quotes regularly from the open market is necessary to find the best prices available.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Safety Service Director is hereby authorized to purchase tires for the various departments and divisions of the City on the open market and at the best prices available for the period January 1, 2024 to December 31, 2024

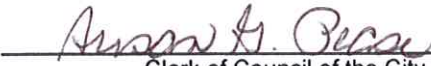
