AN EMERGENCY ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO PURCHASE TWO (2) FORD EXPLORER INTERCEPTORS FROM STATEWIDE FORD LINCOLN/STATEWIDE EMERGENCY PRODUCTS FOR THE POLICE DEPARTMENT AT A COST NOT TO EXCEED \$94,906.00 AS FURTHER DESCRIBED IN EXHIBITS "A" AND "B"

WHEREAS: the Director of Public Safety-Service of the City of Rocky River sourced fully outfitted emergency response vehicles for the purchase of two (2) Ford Explorer Interceptors for the Police Department; and

WHEREAS: the Director of Public Safety-Service has determined it to be in the best interest of the City of Rocky River to accept the pricing for two (2) Ford Explorer Interceptors for the Police Department from Statewide Ford Lincoln/Statewide Emergency Products in the amount of Ninety Four Thousand Nine Hundred and Six Dollars and 00/100 (\$94,906.00), as further described in Exhibits "A" and "B".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service is hereby authorized to purchase two (2) Ford Explorer Interceptors for the Police Department from Statewide Ford Lincoln/Statewide Emergency Products, 1114 West Main Street, Van Wert, Ohio 45891, in the amount of Ninety Four Thousand Nine Hundred and Six Dollars and 00/100 (\$94,906.00), as further described in Exhibits "A" and "B".

SECTION 2. That \$94,906.00 shall be paid from the Equipment Purchase Fund – Popas Vehicles and Large Equipment account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to update the Police Department vehicle fleet and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
