

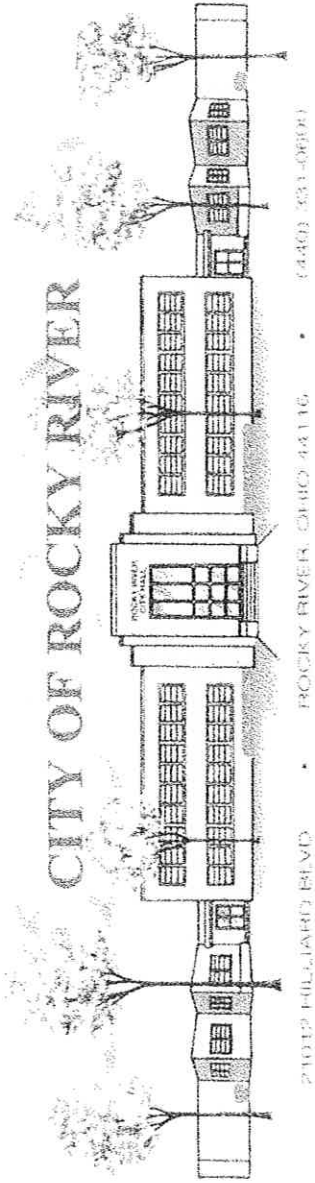

1. Cavalry Mechanics LLC	\$ 97,150.00 *(Incomplete bid submitted)	
2. North Bay Construction	\$ 97,570.00	
3. ABC Piping Co.	\$126,000.00	\$28,430.00

I reviewed the bids with Director of Public Facilities and Maintenance Balla and we agree that the bid by North Bay Construction is the best bid. North Bay Construction provided all required bid documents and there were no irregularities in their bid.
