AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY SERVICE TO PURCHASE PARTS AS NEEDED FROM BEST EQUIPMENT COMPANY, INC., IN AN AMOUNT NOT TO EXCEED \$35,000.00, AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: Best Equipment Company, Inc., has provided the Rocky River Service Department the specialized parts and value for maintenance of the City vehicle fleet; and

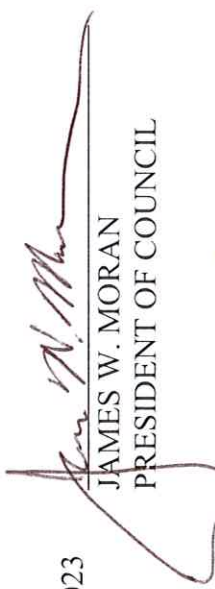
WHEREAS: the City needs to purchase specialized parts for the repair and maintenance of its fleet of vehicles in an amount not to exceed Thirty Five Thousand Dollars and 00/100 (\$35,000.00), as further explained in Exhibit "A"; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety Service is hereby authorized to purchase specialized parts for vehicle repair from Best Equipment Company, Inc., 5550 Poindexter Drive, Indianapolis, IN 46235, in an amount not to exceed Thirty Five Thousand Dollars and 00/100 (\$35,000.00), as further explained in Exhibit "A".

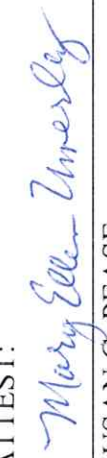

RE: BEST EQUIPMENT COMPANY PURCHASE AUTHORIZATION

We are requesting authorization to expend up to \$35,000.00 with Best Equipment Company. This is not a request for additional appropriations.

Best Equipment Company is the primary dealer in the area for Leach and Loadmaster and Old Dominion Brush equipment which is used for repair of our refuse and leaf collection vehicles. Best Equipment has an excellent service facility and provides efficient support and repair for our vehicle fleet which is used daily, with much wear and tear. This valuable support allows the City to repair and maintain our existing fleet efficiently rather than purchasing new equipment.

In addition, the request would authorize purchases by other departments for equipment and vehicle maintenance, as needed, from already appropriated funds.
