SECTION 1. That the Director of Public Safety-Service is hereby authorized to purchase two (2) Ford F-350 Trucks for the Service Department from Mike Bass Ford, 5050 Detroit Road, Sheffield Village, OH 44035, in the amount of One Hundred Two Thousand One Hundred Forty Eight Dollars and 00/100 (\$102.148.00), as further described in Exhibits "A".

SECTION 2. That \$102,148.00 shall be paid from the Equipment Purchase Fund – Refuse and Recycling and Sanitary Sewer Vehicles and Large Equipment accounts.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary to update the Service Department vehicle fleet and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
