AN EMERGENCY ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO PURCHASE ONE (1) REFUSE SEMI TRAILER FOR THE SERVICE DIVISION FROM REFUSE EQUIPMENT & TRUCK SERVICES, INC., AT A COST NOT TO EXCEED \$141,000.00, AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: the Director of Public Safety-Service of the City of Rocky River advertised for bids for the purchase of one (1) Refuse Semi Trailer for the Service Division; and

WHEREAS: one (1) bid was received on July 21, 2023, for the Refuse Semi Trailer, copy of which is on file in the office of the Director of Public Safety-Service; and

WHEREAS: the Director of Public Safety Service has determined it to be in the best interest of the City of Rocky River to purchase one (1) Refuse Semi Trailer for the Service Division from Refuse Equipment & Truck Services, Inc, at a cost not to exceed One Hundred Forty One Thousand Dollars and 00/100 (\$141,000.00), as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service is hereby authorized to purchase one (1) Refuse Semi Trailer from Refuse Equipment & Truck Services Inc., 237 State Road, Ashtabula, Ohio 44005-1424, at a cost not to exceed One Hundred Forty One Thousand Dollars and 00/100 (\$141,000.00), as further described in Exhibit "A".

SECTION 2. That the funds for said purchase shall be paid from the Equipment Purchase Fund-Refuse and Recycling Vehicles and Large Equipment account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary for the Service Division, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

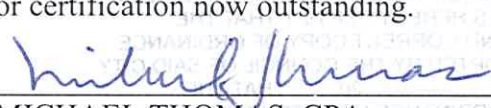
