AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR AND THE SAFETY-SERVICE DIRECTOR TO PURCHASE A CATERPILLAR MINI EXCAVATOR FOR THE SERVICE DIVISION UNDER THE SOURCEWELL COOPERATIVE PURCHASING CONTRACT FROM OHIO CAT EQUIPMENT DIVISION AT A COST NOT TO EXCEED \$152,526.48, AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: the Director of Public Safety Service has determined it to be in the best interest of the City of Rocky River to purchase a Caterpillar Mini Excavator for the Service Division, under the Sourcewell Cooperative Purchasing Contract from Ohio CAT Equipment Division, 3993 East Royalton Road, Broadview Heights, Ohio 44147, at a cost not to exceed One Hundred Fifty Two Thousand Five Hundred Twenty Six Dollars and 48/100 (\$152,526.48), as further described in Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA STATE OF OHIO:

SECTION 1. That the Mayor and the Director of Public Safety-Service are hereby authorized to purchase a Caterpillar Mini Excavator for the Service Division, under the Sourcewell Cooperative Purchasing Contract from Ohio CAT Equipment Division, 3993 East Royalton Road, Broadview Heights, Ohio 44147, at a cost not to exceed One Hundred Fifty Two Thousand Five Hundred Twenty Six Dollars and 48/100 (\$152,526.48), as further described in Exhibit "A".

SECTION 2. That the funds for said purchase shall be paid from the Equipment Purchase Fund-Sanitary Sewer Vehicles and Large Equipment account.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health and safety, and for the further reason that it is necessary for the Service Division, and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

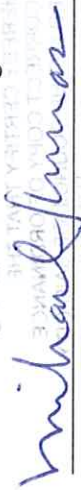

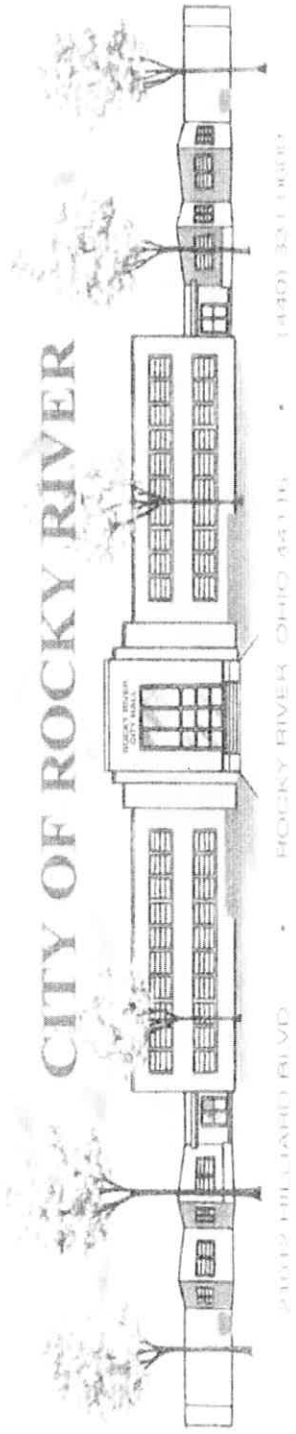
