AN EMERGENCY ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS
FOR THE CURRENT EXPENSES OF THE CITY OF ROCKY RIVER, OHIO,
DURING THE FISCAL YEAR ENDING DECEMBER 31, 2023
AND TO AMEND AMENDED ORDINANCE NOS. 77-22; 17-23; 54-23 AND 75-23

WHEREAS: To provide for the current expenses of the City of Rocky River, Ohio, for the fiscal year ending December 31, 2023, City Council adopted an annual appropriation ordinance, Amended Ordinance No. 77-22, and;

WHEREAS: The City of Rocky River, Charter, Article VII, Section 6 (1990) provides that City Council may amend or supplement the annual appropriation ordinance after its passage, and;

WHEREAS: To provide for the current expenses of the City of Rocky River, Ohio, for the fiscal year ending December 31, 2023, City Council adopted Amended Ordinance Nos. 17-23; 54-23 and 75-23 as supplemental appropriations, and;

WHEREAS: The unanticipated financial needs of the City require supplemental appropriations for current expenses as provided in the attached Exhibit "A".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

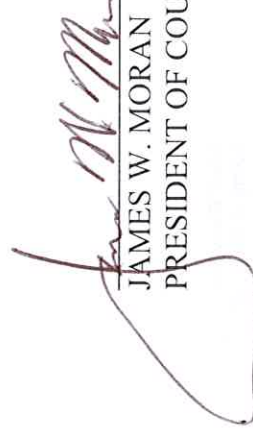
SECTION 1. - That to provide for the current expenses of the City of Rocky River, Ohio, during the fiscal year ending December 31, 2023, the sums provided in the attached Exhibit "A" be and they are hereby set aside and appropriated in addition to the provisions of Amended Ordinance Nos. 77-22; 17-23; 54-23 and 75-23.

SECTION 2. - That Amended Ordinance Nos. 77-22; 17-23; 54-23 and 75-23 regarding appropriations and supplemental appropriations for the current expenses of the City of Rocky River, during the fiscal year ending December 31, 2023 are hereby amended.

SECTION 3. - Except as amended in Section 1 of this Ordinance, Amended Ordinance Nos. 77-22; 17-23; 54-23 and 75-23 shall remain in full force and effect.

SECTION 4. - That this Ordinance is hereby declared to be an emergency measure, necessary for the immediate preservation of public peace, health and safety, and for the further reason that unanticipated financial needs require supplemental appropriations and provided it receives the affirmative vote of two-thirds (2/3) of all members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

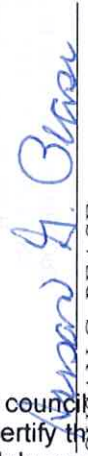
