ORDINANCE NO. 96-23

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY-SERVICE TO ENTER INTO AN AGREEMENT FOR A PERIOD OF ONE YEAR FOR THE REMOVAL OF GRIT AND SCREENINGS TO A MUNICIPAL LANDFILL FOR THE WASTEWATER TREATMENT PLANT FROM KIMBLE COMPANY, AT A COST OF \$98.73 PER TON AS FURTHER DESCRIBED IN EXHIBIT "A"

WHEREAS: The Director of Public Safety-Service of the City of Rocky River advertised for bids with specifications that contain an option to renew on an annual basis for the removal of grit and screenings to a landfill from the Wastewater Treatment Plant in 2023; and

WHEREAS: November 3, 2023, one (1) bid was received and upon recommendation of the Waste Water Treatment Plant Superintendent, it was determined to be in the best interest of the City to accept the lowest and best bid, for the removal of grit and screenings to a landfill from the Wastewater Treatment Plant from Kimble Company, for a period of one (1) year, copies of bids are on file in the office of the Director of Public Safety Service; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ROCKY RIVER, COUNTY OF CUYAHOGA, STATE OF OHIO:

SECTION 1. That the Director of Public Safety-Service of the City of Rocky River is hereby authorized to purchase services for the removal of grit and screenings to a municipal landfill for a period of one year, with an option to renew from Kimble Company, 3596 State Route 39 NW, Dover, Ohio 44622 at the price of \$98.73 per ton.

SECTION 2. That funds for the removal of grit and screenings to a municipal landfill shall be paid from the Wastewater Treatment Plant Utility Fund.
